<ul> <li>Order Comms</li> <li>Favourite folders for commonly requested tests which can be tailored to clinician, specialty discipline or patient condition</li> <li>Electronic results endorsing, view results and document action taken</li> <li>Trend results</li> <li>Clinical messaging including transfer of patients results to another clinician</li> <li>Phlebotomy</li> </ul>	<ul> <li>Paper request for tertiary hospitals</li> <li>Consent forms</li> </ul>
<ul> <li>PAS</li> <li>Automatic modifying of follow up appointments</li> <li>Offer Forms - to cancel appointments with correct logic reasons</li> <li>Logic to stop encounters being utilized more than once for first appointments</li> <li>Ward discharge requests for follow up appointments</li> <li>Order Comms requests for follow up appointments</li> </ul>	The ability to remove the existing encounter when rescheduling an appointment.
